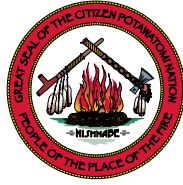

The following items must be completed and returned to our office before your court appearance:

1. Application For Admission to Practice
2. Advocates Oath – Must be Notarized
3. A clear photocopy of your State of Oklahoma Bar Association Card
4. A Letter of Good Standing from the Oklahoma Bar Association
5. A check or money order for \$50 made payable to "CPN Tribal Court" for the admission fee

These items can be returned to the Tribal Court Clerks' Office either in person or by mail. Once properly completed and received, you will be admitted to our bar.
