# DO NOT FILL IN THE BLANKS AND RETURN THE COPY FOR FILING. TYPE A PETITION FOR SUBMISSION TO THE COURT.

The fee for filing this petition is \$55.00 in the form of a cashier's check or money order made payable to the Citizen Potawatomi District Court. Please sign your money order.

You will also be provided a Combined Order and Notice of Hearing Petition to be retyped. At the time of filing the Court Clerk's office will provide a court date. This Order and Notice will have to be published 1 time, 30 days before the hearing date, in a newspaper where you live.
